Founded in 2009, La Boîte Aux Enfants specialises in the management of indoor leisure parks offering fun activities for children from 1 to 12 years old, through adventure courses, sports activities and entertainment.

Turenne Groupe and M Capital, shareholders in the company since 2014, were joined in 2021 by Bpifrance via its France Investissement Tourisme 2 fund, in order to accelerate external growth. The company, a leader in its market, now consists of 25 parks in France, welcomes more than 2 million visitors per year and generates revenue of €18 million.

Having proven the resilience of its model during the health crisis, La Boîte Aux Enfants thus confirmed its leading position by becoming the main consolidation platform in the sector.

After years of support from its long-standing investors, M6 is now acquiring the LBAE Group in order to pursue its investment strategy geared to families, around Gulli, France's leading youth channel.

After finalisation of the documentation, the transaction is expected to be closed in early July 2024.

Gaëtan Le Jariel, Chairman of La Boîte Aux Enfants commented: "During these 15 years of a very rich entrepreneurial adventure, we have had the pleasure of offering wonderful moments of joy to millions of children.

This was made possible thanks to the exceptional teams, who I would like to congratulate, because it is their day-to-day work that makes the company so valuable!

I am very pleased with this sale to M6: it makes a lot of sense and will be positive for the group's continued development, which we will be happy to support."

The acquisition by the M6 Group rewards the remarkable work of the management and thus allows the strong development of the Gulli Parcs to continue."
