This document provides you with key investor information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

WHAT IS THE PRODUCT ?

TYPE

The Fund is a sub-fund of EdR Private Equity Select Access Fund II S.A., SICAV-RAIF, a *société anonyme* incorporated under the laws of Grand Duchy of Luxembourg as a *société d'investissement à capital variable – fonds d'investissement alternatif réservé*, established and existing under the laws of the Grand Duchy of Luxembourg, whose registered office is at 4, rue Robert Stumper, L-2557 Luxembourg, Grand Duchy of Luxembourg. The Fund qualifies as an alternative investment fund within the meaning of the Directive 2011/61/UE on alternative investment fund managers (the "AIFMD") as implemented in Luxembourg by the law of 12 July 2013 on alternative investment fund managers, as amended from time to time (the "AIFM Law"). Edmond de Rothschild Private Equity Luxembourg S.A. (the "AIFM") has been entrusted with the portfolio management and risk management of the Fund.

OBJECTIVES

The Fund is a feeder fund of Amethis Europe Expansion, a French professional private equity fund (the "Master Fund"). The objective of the Fund is to invest all of its assets in the Master Fund net of fees and expenses.

The Master Fund will invest mainly in Companies whose principal economic activity is located in France, it being specified that their registered office may be located elsewhere provided that they carry out their activity in France. In addition, the Master Fund will invest, on an ancillary basis, in Companies whose principal economic activity is located in Europe.

The Master Fund is intended to hold a minority or majority share of the capital of the Companies in which it invests. The Master Fund will invest in equity securities or equivalent financial instruments.

The Master Fund may invest in monetary funds or other short-term negotiable instruments which are low risk and not speculative notably (i) any capital which has been called but not yet invested and (ii) Net Proceeds (as such term is defined in the Master Fund By-Laws) in anticipation of distribution or set aside including for payment of costs and expenses.

The Master Fund will have a term of 10 years from the date of commencement with the option to extend the term by one year twice consecutively from the expiry of the term, as described in the Master Fund documentation.

The Master Fund does not intend to invest (i) more than 15) % of the Total Commitments in a single Company, provided that the Master Fund may nevertheless invest up to 20% of the Total Commitments in a single Company when the additional five 5% represents a Temporary Investment; (ii) more than 10% in Companies whose securities, at the time of the initial investment of the Master Fund, are listed on a Market; notwithstanding the foregoing, the Master Fund may invest in public to private transactions or in private investment in public equity (PIPE) transactions.

The Fund promotes environmental and social characteristics in the sense of Article 8 of the EU SFDR and takes into account sustainability risk. It does not make investments aligned with the European Taxonomy. For more details on the investment objectives and strategy of the Master Fund, please refer to the Master Fund Rules.

INTENDED RETAIL INVESTOR

The Fund is intended to be marketed to institutional, professional, and well-informed investors. Retail investors who would like to invest in the Fund must qualify as retail investors, pursuant to the Regulation (EU) No 1286/2014 of the European Parliament and of the Council of 26 November 2014 on key information documents for packaged retail and insurance-based investment products (PRIIPs), who have sufficient experience and theoretical knowledge of private equity funds, who are seeking exposure to a closed-ended investment which are able to bear the loss of their entire investment and who have a long-term investment horizon.

TERM

The Fund is established for a limited duration of ten (10) years as from the formation date of the Master Fund with extensions options by the sole decision of the Board of Directors if extensions at the level of the Master Fund so require, and with the possibility for the Board of Directors to decide an earlier termination of the Fund depending on the timing of exits at the level of the Master Fund, at its sole discretion.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator



The risk indicator assumes you keep the product until the term of the fund. You cannot cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 6 out of 7, which is the second highest risk class.

This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the capacity of the Fund to pay you.

Changes to tax laws/treaties may adversely affect returns on your investment. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment.

WHAT HAPPENS IF THE FUND IS UNABLE TO PAY OUT?

Losses are not covered by an investor compensation or guarantee scheme. Furthermore, with respect to Edmond de Rothschild (Europe) S.A. as depositary of the Fund responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited due to the rules set out in Article 19 of the AIFM Law and in the Commission Delegated Regulation (EU) 231/2013, which require a segregation of assets between those of the Depositary and the Fund. The Depositary is liable to the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control. For all other losses, the Depositary is liable in case of its negligent or intention failure to properly fulfil its obligations pursuant to the AIFM Law and any applicable rules and regulations.

WHAT ARE THE COSTS ?

COSTS OVER TIME

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of (i) the product itself and (ii) the Master Fund. They exclude potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.

¹ The average return each year cannot be compared to a net internal rate of return (IRR), a widely used performance metric for private equity funds that considers the timing and size of capital calls and distributions for investors. The EU PRIIP Regulation prescribes another method (i.e., not IRR) for performance scenarios, which is a time weighted annual return over the recommended holding period that does not take into consideration the timing of investor cashflows.

² Your maximum commitment in the Fund, called over the life of the product, and you receive the proceed upon disposal of investments by the Fund over the life of the product.

COMPOSITION OF COSTS

The table below shows the impact each year of the different types of costs on the investment return you might get at the end of the recommended holding period and the meaning of the different cost categories.

One-off costs	Entry costs	-	The impact of the costs you pay when entering an investment. This is the most you will pay, and you could pay less.
	Exit costs	-	The impact of the costs of exiting your investment when it matures.
Ongoing costs	Portfolio transaction costs	10	The impact of the costs of us buying and selling underlying investments for the product.
	Other ongoing costs	135	The impact of the costs that we take each year for managing your investments and the costs previously presented.
Incidental costs	Performance fees	-	The impact of performance fees. We take these from your investments if the product outperforms its benchmark.
	Carried interests	-	The impact of incentive fees. We charge this amount when the performance of the investment is above 8% and below 10%. If the performance is above 10%, a payment of 80% of the differential between the final return and the threshold rate will be made to investors after the exit of the investment.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

REQUIRED MINIMUM HOLDING PERIOD: 10 YEARS

The Fund is a closed-ended fund, meaning that shares may not be redeemed at the request of the investors prior to the liquidation of the Fund. The required minimum holding period, in principle, is 10 years starting on the Last Closing³ date of the Fund as further described under the "Term" heading.
