WHAT IS THE PRODUCT?

TYPE

The Fund is a sub-fund of EdR Private Equity Select Access Fund II S.A., SICAV-RAIF, a société anonyme incorporated under the laws of Grand Duchy of Luxembourg as a société d'investissement à capital variable – fonds d'investissement alternatif réservé, established and existing under the laws of the Grand Duchy of Luxembourg, whose registered office is at 4, rue Robert Stumper, L-2557 Luxembourg, Grand Duchy of Luxembourg. The Fund qualifies as an alternative investment fund within the meaning of the Directive 2011/61/UE on alternative investment fund managers (the "AIFMD") as implemented in Luxembourg by the law of 12 July 2013 on alternative investment fund managers, as amended from time to time (the "AIFM Law"). Edmond de Rothschild Private Equity Luxembourg S.A. (the "AIFM") has been entrusted with the portfolio management and risk management of the Fund.

OBJECTIVES

The Fund is a feeder fund of PeakBridge Growth II S.C.A. SICAV-RAIF (hereinafter the "Master Fund"), a corporate partnership limited by shares incorporated and existing under the laws of the Grand Duchy of Luxembourg as an investment company with variable share capital, organized as a reserved alternative investment fund, having its registered office at 4, rue Robert Stumper, L-2557 Luxembourg, Grand Duchy of Luxembourg and registered with the Luxembourg Trade and Companies Register under number B264337, represented by its general partner PeakBridge Growth II GP S.à r.l., a private limited company, incorporated and existing under the laws of the Grand Duchy of Luxembourg, having its registered office at 4, rue Robert Stumper, L-2557 Luxembourg, Grand Duchy of Luxembourg and registered with the Luxembourg Trade and Companies Register under number B264241.

The Master Fund will have an initial fixed term of ten (10) years commencing on the initial closing date, extendable by two (2) consecutive one (1) year periods, as further described in the Master Fund's documentation.

The Master Fund seeks to make equity and equity related Investments in portfolio companies focusing in scalable technologies for the agri-food industry, with the goal to achieve above average return of investment.

The Master Fund will notably invest in Series A-B agri-food tech opportunities including, but not limited to, alternative protein technologies, digitalization and food system 4.0, alternate farming systems, ingredient innovations, and nutrition & health (Primary Focus).

The Master Fund may, on an opportunistic basis, invest up to ten percent (10%) of total commitments of the Master Fund outside the Primary Focus, provided that the target portfolio company is active in the agrifood industry.

The Master Fund contemplates to make approximately fifteen to eighteen investments at an average of eight million euros (EUR 8,000,000) investment per portfolio company.

The portfolio companies shall be located in Member States of the EU, of the European Free Trade Association (EFTA), of the European Economic Area (EEA), the United Kingdom and any state that is affiliated to EU's funding program for research & innovation "Horizon Europe" as defined at the initial closing of the Master Fund, Israel, United States of America and Canada

INTENDED RETAIL INVESTOR

The Fund is intended to be marketed to institutional, professional, and well-informed investors. Retail investors who would like to invest in the Fund must qualify as retail investors, pursuant to the Regulation (EU) No 1286/2014 of the European Parliament and of the Council of 26 November 2014 on key information documents for packaged retail and insurance-based investment products (PRIIPs), who have sufficient experience and theoretical knowledge of private equity funds, who are seeking exposure to a closed-ended investment which are able to bear the loss of their entire investment and who have a long-term investment horizon.

TERM

The Fund is established for a limited duration of ten (10) years as from its First Closing, which may be extended for a maximum of a further two (2) consecutive one (1) year periods and with the possibility for the Board of Directors to decide an earlier termination of the Fund depending on the timing of exits at the level of the Master Fund, at its sole discretion.

WHAT ARE THE RISKS AND WHAT COULD LIGHT IN RETURN?

Risk Indicator





The risk indicator assumes you keep the product until the term of the fund. You cannot cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. WHAT HAPPENS IF THE FUND IS UNABLE TO PAY OUT?

Losses are not covered by an investor compensation or guarantee scheme. Furthermore, with respect to Edmond de Rothschild (Europe) S.A. as depositary of the Fund responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited due to the rules set out in Article 19 of the AIFM Law and in the Commission Delegated Regulation (EU) 231/2013, which require a segregation of assets between those of the Depositary and the Fund. The Depositary is liable to the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control. For all other losses, the Depositary is liable in case of its negligent or intention failure to properly fulfil its obligations pursuant to the AIFM Law and any applicable rules and regulations.

WHAT ARE THE COSTS?

COSTS OVER TIME

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of (i) the product itself and (ii) the Master Fund. They exclude potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

REQUIRED MINIMUM HOLDING PERIOD: 10 years

The Fund is a closed-ended fund, meaning that shares may not be redeemed at the request of the investors prior to the liquidation of the Fund. The required minimum holding period, in principle, is 10 years starting on the Last Closing³ date of the Fund as further described under the "Term" heading.
