



The Edmond de Rothschild Group strengthens its management team in Switzerland

Meeting today under Chairman Benjamin de Rothschild and Vice-Chairwoman Ariane de Rothschild, the Boards of Directors of Edmond de Rothschild Holding S.A. and Banque Privée Edmond de Rothschild S.A. made several appointments to strengthen governance of the Group and its subsidiary in Switzerland. Christophe de Backer, Group CEO since 26 April 2012, has become Chief Executive Officer of the Group holding company, Edmond de Rothschild Holding S.A., which is now the Group's lead operational structure.

Emmanuel Fievet, an international private banking specialist, has joined the Group as Chief Executive Officer of Banque Privée Edmond de Rothschild S.A., the Group's Swiss subsidiary. He will also head International Private Banking for the Group. He has joined the Group Executive Committee and reports to Christophe de Backer.

"These important changes mark a major step in our Group's development and governance. I am very pleased to welcome Emmanuel Fievet, an esteemed Private Banking professional. He will work with all the teams to contribute actively to our Group's success", commented Benjamin de Rothschild.

Manuel Leuthold, who since February 2012 has served as Deputy Chief Executive Officer at Banque Privée Edmond de Rothschild S.A., has joined Edmond de Rothschild Holding S.A. as Group Chief Administrative Officer with responsibility for managing Group support functions.

Jean-Luc Besençon, Head of Human Resources at Banque Privée Edmond de Rothschild S.A., has been appointed Group Head of Human Resources and Sustainability. He will join the Group Executive Committee, replacing Bénédicte Chrétien, who is leaving the Group. He will report to Manuel Leuthold.

Jérôme Moser and **Marc-Henri Balma**, respectively Head of Risk and Head of Operations at the Swiss subsidiary, will join the Executive Committee of Banque Privée Edmond de Rothschild S.A.

In 2005, he joined UBS Wealth Management in London as Head of Sales Management & Deputy Head of UK Domestic. He then became Head of the UK Domestic business and a member of the UK Management Team.
